



## Self-Tech Inspection Form

This form must be completed and signed by the person who inspected and approved the following items. If you are not qualified to inspect your own vehicle, it must be inspected by someone who is qualified, and who signs below. (**INSPECTOR** – please indicate compliance as  and indicate non-compliance as ):

**SUSPENSION :**

- SHOCKS - in good condition, no leaks.
- SUSPENSION - mounts firm.
- WHEEL BALANCE - properly adjusted.
- STEERING LINKAGE - tight.
- TIRES - good condition, enough tread to FINISH the event, "V" or higher speed rating.

**ENGINE AND DRIVE TRAIN :**

- MOTOR MOUNT - secure.
- ENGINE BREATHER - not open to atmosphere.
- DRIVE LINE - secure.
- OIL&FLUID LEAKS - none major.
- DRIVE BELTS - good condition.
- EXHAUST SYSTEM - secure, no leaks.

**HELMET&SAFETY :**

ALL VEHICLES EQUIPPED WITH A 4-5-6 POINT HARNESS MUST USE A HANS-FHR NECK RESTRAINT DEVICE – EXCLUDING THE SCHROTH QUICK FIT 4 POINT HARNESS.

- HELMET FREE OF VISIBLE DAMAGE
- Snell SA2015 or newer - required for all cars equipped with roll bar or roll cage.
- Snell M2015 or newer - sufficient for cars NOT equipped with roll bar or roll cage.
- HANS DEVICE - Required if using a 4-5-6 point harness. EXCLUDING THE SCHROTH QUICK FIT 4 POINT HARNESS.

**BODY AND ELECTRICAL :**

- ROLL BAR or ROLL CAGE - Required in all open cars.
- SEAT BELTS - minimum 3-point factory restraints, all secure and in good condition. Same for driver and passenger (not lesser restraints for passenger).
- SEATS - secure.
- BATTERY - secure.

**BRAKES :**

- PEDAL - firm.
- LINING - over 50% pad thickness recommended.
- FLUID - not older than 6 months.
- HYDRAULIC LINES/CALIPERS - no leaks, no cracks in rubber hoses.
- BRAKE LIGHTS - all are working.

**MUFFLERS :**

- EXHAUST LESS THAN 92dB @ 50 ft. - required for participants receiving instruction so that instructor and student can communicate.
